MEWP Supervisor Course

Course Description

This Mobile Elevating Work Platform (MEWP) Supervisor course covers all aspects of the role and duties of those who plan, supervise or manage the use of MEWPs to ensure work at height is undertaken safely, as well as ensure suitable incident prevention strategies are implemented.
